**ROLL CALL** The meeting was called to order at 5:30PM, by President Jeff Tilly. Recording secretary Emily Wendlandt called the roll.

PLEDGE of ALLEGIANCE Gloria Lind led the assemblage in the Pledge of Allegiance.

**APPROVAL of AGENDA and MINUTES** Gloria Lind made a motion to approve the minutes for the July 17, 2024 meeting. **Motion passed unanimously**.

## PUBLIC PARTICIPATION, AWARDS, and PRESENTATIONS

**Mike Brien** presented to the board the proposed Natural Resource shop at Severson Dells Forest Preserve that is in the 2024/2025 fiscal year budget. Mike Brien explained to the board that the Natural Resource department is growing at a rapid rate and is in need of a new facility that can handle their workload. He then gave a brief overview of the steps that will need to be taken as well as the projected cost in order to achieve the desired infrastructure.

Alex Mills presented to the board the OSLAD grant opportunity for the proposed renovation and expansion of the Clarcor Pavilion restrooms at Klehm Arboretum and Botanic Garden. Mills gave a breakdown of some of the issues that have risen due to the conditions of these restrooms such as the current size and location. He also explained that the pavers leading to the restrooms do not comply with ADA standards, making it difficult for guests with disabilities to use these restrooms safely. Mills provided the board with photos of the restrooms' current condition, a blueprint of the desired renovation and the projected cost. Mills finally shared with the board the responses he had received from a public survey that was posted to Klehm Arboretum and Botanic Garden's social media about the proposed renovations of the Clacor Pavilion restrooms, to which the public responded in agreeance to.

**Sue Grans**, a volunteer and Tour Guide at Klehm Arboretum and Botanic Garden, addressed the board to provide insight as to how much the organization would benefit from the renovation and expansion of the Clarcor Pavilion restroom. Grans explains that many groups small and large use the Clacor restrooms regularly and it would be a massive benefit to them if the restrooms were updated. She concluded by saying that we are all benefitting from Klehm Arboretum's success and growth and asked for the board's support.

**Barb Chidley**, who works for the city of Rockford, addressed the board to ask for their support in the renovations of the bathrooms. Chidley has been working with Alex and Klehm Arboretum on a project to bring more accessibility to senior citizens to Klehm Arboretum. Chidley brings up that the bathrooms are a deterrent for groups wanting to use the facilities and that, because she works closely with senior citizens, it is crucial that these bathrooms become ADA compliant.

Wes Burandt, a member of the board of directors at Klehm Arboretum, said that he stands by this project and is in full support.

**Clark Wangaard**, who serves on the Klehm Arboretum board, explained that Klehm is growing into becoming a regional entity and that the need for the expansion is beginning to become a desperate one due to the volume of new participants.

Steve Chapman presented to the board the draft budget for the 2024/2025 fiscal year. Mike Holan presented to the board the improvement projects and equipment's section.
